





# THE SPEAKER PORTAL



By now, you should have received an email with your **Speaker Portal** login credentials.



**WEF Members** (current and past) should use their WEF membership username and password.



**Non-members** should use the username and password provided in speaker portal notifications.



# WHO IS THIS SESSION FOR?

## Primary Authors

- Submitted abstract to Call for Content.
- Responsible for submitting [full technical paper](#).

## Invited Speakers

- Received invitation from WEFTEC Program Community to speak.
- Responsible for [submitting presentation slides](#).
- Responsible for giving presentation at WEFTEC.
- *Technical Paper submission is optional.*

## Presenting Authors

- Responsible for [submitting presentation slides](#).
- Responsible for giving presentation at WEFTEC.

# PRIMARY AUTHORS

**Authors** main responsibility is to submit the presentation's technical paper. There can only be **one** primary author. Only this person can submit the final paper.

## Additional Responsibilities

- Inputting the short summary (100 words or less) into the speaker portal.
- Finalizing co-author list in speaker portal. This includes removing incorrect co-authors and adding missing co-authors.
- Ensuring the final paper title matches what is in the speaker portal.

## Deadlines

Technical Paper, Co-author Listing, and Short Summaries are all due on **July 21<sup>st</sup> at 9:00 AM Eastern.**

# TECHNICAL PAPER GUIDANCE

The [guidance document](#) and [template](#) for the technical paper can be found in the speaker portal.

**All technical papers must be submitted in PDF formatting according to the provide guidelines.**

If your abstract was accepted through the WEFTEC 2025 Call for Content, you must submit a technical paper (4-page minimum) for the conference proceedings.

For primary authors, session proposals and invited speakers who will be writing full papers for the conference proceedings, download and review our paper guidance to ensure your paper meets the requirements for submission. Papers submitted that do not meet these guidelines will be asked to resubmit.



# INVITED SPEAKERS

**Invited Speakers** are not required to submit technical papers but are highly encouraged to do so.

*If you opt-out of submitting a paper, you do not need to sign the license agreement.*


## Choosing to Submit

- If you choose to submit a paper for the conference proceedings, you need to follow the same guidance provided in the speaker portal.
- You must also add in any co-authors into the speaker portal. The added co-authors and you must sign the license agreement.

## Deadlines

Technical Papers and Co-authors are due on **July 21<sup>st</sup> at 9:00am Eastern.**

# CO-AUTHORS



Sole responsibility is providing **e-signature** on the license agreement. They will receive instructions when the license agreement opens.



Each co-author will have their own speaker portal with their license agreement.



Authors must **add their co-authors** to the portal before the August 22<sup>nd</sup> deadline for them to sign.

# PRESENTING AUTHORS

**Presenting Authors** are responsible for creating, uploading, and giving the presentation onsite at WEFTEC.

## **Additional Responsibilities**

- Confirming speaker list in speaker portal. Removing incorrect speakers and adding missing speakers.
- Uploading introduction(bio) and photo to the speaker portal.
- Attending one of the two Pre-WEFTEC briefings.

*\*Only presenting authors will be able to upload the presentation slides.*

## **Deadlines**

A draft of your presentation slides must be uploaded to the portal by **September 22<sup>nd</sup>**.

# INTRODUCTION & PHOTO UPLOAD


All **invited speakers** and **presenting authors** will need to input a short introduction to introduce themselves and a photo.

The moderator/facilitator for the session will introduce you to the audience using the intro provided.

The introduction should not be longer than 100 words.


Photo must be upload in .jpg or .png format.
